

Conflict Prevention/Resolution

Our strategy for conflict prevention and peaceful resolution has several approaches: analysis, education and dialogue for conflict management and transformation. Experts of ICCN work on identification

and analysis of symptoms in conflict situation; conduct trainings for IDPs, returnees, women, young journalists aimed at capacity building, empowerment, increase participation, personal development, and civic education.

ICCN coordinates the South Caucasus regional process for the Global Partnership for the Prevention of Armed Conflict. The whole process and concrete activities is undertaken within the following directions: 1) Dialogue and Mediation; 2) Civil Society interaction with regional and UN agencies; 3) Awareness Raising, Knowledge Generation and Sharing/Peace education; 4) Network Capacity Building;



Human Rights/Integration of Minority Groups/Gender Issues

ICCN works to increase awareness of community at large about diversity issues and improve acceptance of ethnical and religion minority groups by youth, media representatives, local governments, and general public

ICCN has established The Civil Council for the Protection of Basic Rights and Freedoms. The council is evaluating and then analyzing the attitudes of the population towards ethnic, religious minorities, the decision-making bodies, the mainstream church, etc.

ICCN program is sequentially working on elaborating and applying of gender sensitive and equitable approaches. ICCN provides Training of Trainers for Target Group Education in the framework of 'Combating Gender-Based Violence in the South Caucasus' Project (UNFPA). Training curriculum created by ICCN experts focus on Gender Based Violence awareness, covering scope of the problem, definitions, dynamics, interventions, legal and ethnical issues and prevention.

Civil Society Development

To foster liberal values is one of the most important tasks for ICCN. We keep active and overwhelming discussions on issues like: freedom, freedom as development, freedom of expression, religion, peace, non-violent approaches diversity, intercultural dialogue, human rights, the role of government and civil society in the transformation and euro-Atlantic integration processes.
